## **Vendor Rules**

- 1. Set up will be from 7:00 AM 10:00 AM. All vehicles must be removed from the park area by 9:45 am. Late arrivals will not be allowed to set up and will forfeit any vendor fees.
- 1. Booth assignment is at the sole discretion of the Town of Esto.
- 2. Vendors must provide their own display set-up: tent, panels, tables, chairs, etc. Vendors should have tent weights and all tents must be properly weighed down.
- 3. This is a rain or shine event and will only be cancelled in case of severe weather. No refunds will be given if severe weather does cause a cancellation.
- 4. Food vendors are responsible for the compliance of their operations with the Florida Department of Business & Professional Regulation. A listing of DBPR food service regulations is available at <a href="http://tinyurl.com/2enjny47">http://tinyurl.com/2enjny47</a>.
- 5. Vendors will not have access to electricity or water sources.
- 6. The Town of Esto reserves the right to request the removal of inappropriate crafts and/or displays, and vendors selling unauthorized items will be asked to remove those items.
- 7. Vendors are responsible for disposing of their own trash.
- 8. All vendors are expected to remain until 2:00 PM. Vendors wanting to leave early must notify an event organizer. Early departures may exclude you from future participation in Town of Esto events including the Two-Toed Tom Festival.
- 9. For safety reasons, vendors cannot bring their vehicles into the park area until after 2:00 PM.
- 10. Vendors are responsible for filing their own taxes with the state.

Vendors who do not abide by the rules may be asked to leave immediately. Violation of these rules will exclude vendors from participating in future Town of Esto events and may result in the loss of vendor space without a refund.
