## ORDINANCE 2025-01 AN ORDINANCE OF THE TOWN COUNCIL OF ESTO, FLORIDA, PROHIBITING SMOKING AND VAPING IN PUBLIC PARKS WITHIN THE TOWN.

Summary of the proposed ordinance:
 In order to provide for the public health, safety, and welfare, reduce exposure to secondhand smoke, and assure cleaner parks, it is the intent of the Esto Town

Council, to prohibit smoking and smoking waste in parks.
