NOTICE OF PUBLIC HEARING

The Town Council of the Town of Esto proposes to adopt OR-DINANCE 2025-03:

AN ORDINANCE OF THE TOWN OF ESTO, FLORIDA, PROHIBITING DAMAGE TO PUBLIC PROPERTY AND INFRASTRUCTURE: ESTABLISHING ENFORCE-MENT MEASURES, PENALTIES, AND COST RECOVERY: PROVIDING FOR A PERMITTING PROCESS FOR AUTHORIZED USES: PROVIDING FOR A MEMBER PROCESS: PROVIDING FOR CONFLICTS, SEV-ERABILITY, AND AN EFFECTIVE DATE.

A Public Hearing on Ordinance 2025-03 was held by the Town Council Tuesday, April 15, 2025, and a Second and Final Hearing will be held Tuesday, May 20, 2025, at 7:00 p.m., or as soon thereafter as possible, at Esto Town Hall, 3312 2nd Ave South, Esto, Florida. The Town Council may continue or defer the hearing to a new date and time of the continuance or deferral is announced at the hearing. The Ordinance in its entirety may be inspected at the Office of the Town Clerk during regular working hours.

Pursuant to Florida Statutes 286.0105, if a person decides to appeal any decision made by the Town Council with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes testimony and evidence upon which the appeal is to be based.

Any and all interested parties may appear at the above meeting and be heard with respect to the proposed items. In accordance with the Americans with Disabilities Act and Florida Statutes Section 286.26, persons needing a special accommodation to participate in this proceeding should contact the Town Clerk's Office at (850) 263-6521 at least 48 hours prior to the meeting.
